**NOTICE CONVENING THE ADJOURNED 'TRIBUNAL CONVENED MEETING OF THE SECURED CREDITORS OF NCC LIMITED'**

To,

The Secured Creditors of NCC Limited (the "Applicant Company")

By an order pronounced on 29<sup>th</sup> November 2024, the Hon'ble Hyderabad Bench of the National Company Law Tribunal ("NCLT", and such order, the "Order") in the above mentioned Company Application, a meeting of Secured Creditors of NCC Limited ("hereinafter referred to as "Applicant Company" or the "Transferee Company") was directed to be convened on Thursday, 30<sup>th</sup> January 2025 at 12:00 Noon at the Registered Office of the Applicant Company at NCC House, Madhapur, Hyderabad, Telangana, India, Pin-500081 to be held for the purpose of considering, and if thought fit, approving the Scheme of Arrangement proposed between NCC Infrastructure Holdings Limited (the "Transferor Company") and NCC Limited (the "Transferee Company") and their respective Shareholders (hereinafter the "Scheme").

Pursuant to the Order, a meeting of the secured creditors of the Applicant Company was convened and held on 30<sup>th</sup> January 2025 at 12:00 Noon at the Registered Office of the Applicant Company and by providing facility for voting in person or by proxy. At the meeting, the Chairman appointed by NCLT received a request from majority of the Secured creditors to adjourn the meeting. Accordingly, the adjourned meeting was held on 16<sup>th</sup> April 2025.

At the adjourned meeting fourteen (14) Secured Creditors, representing 70.55% in value of the total outstanding debt to the Secured Creditors were present at the meeting with valid authority. A representation was made to the Chairman by the Working Capital Consortium lenders, consisting of Banks including Public Sector Banks, holding about 59% of the total value of the outstanding debt due to the Secured Creditors, to adjourn the meeting for 2 months. In such circumstances, during the meeting, the Chairman ascertained the motion for adjournment through a voice vote. Upon determining that the requisite support for adjournment was received through the voice vote by the Secured Creditors of the Applicant Company, the Chairman adjourned the meeting to Monday, 16<sup>th</sup> June 2025, subject to the directions of the Hon'ble NCLT. The Hon'ble NCLT pronounced an order on 26<sup>th</sup> May 2025 to proceed in accordance with the Orders dated 29<sup>th</sup> November 2024, particularly para no. (j), page no. 19, regarding the Chairman's power to adjourn the meeting.

Accordingly, take notice that the adjourned meeting of the secured creditors of the Applicant Company will be held on Monday, 16<sup>th</sup> June 2025 at 11:30 A.M., and Secured Creditors may attend either in person or by proxy. At the adjourned meeting, the resolution, as sought for in the Notice for the Tribunal Convened Meeting of the Secured Creditors of NCC Limited dated 26<sup>th</sup> December 2024 ("**Notice**"), which was earlier sent to the secured creditors of the Applicant Company, will be considered, and if thought fit, be passed, with or without modification(s).

The contents of the Notice, other than the date and time of the adjourned meeting as referred hereinabove, remain unaltered.

A copy of (a) the Scheme; (b) the explanatory statement under Sections 230(3) and 102 of the Companies Act, 2013 read with Rule 6(3) of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016 and (c) the enclosures as indicated in the index to the Notice (collectively referred to as the "**Particulars**") have already been sent earlier to the secured creditors of the Applicant Company along with the Notice. 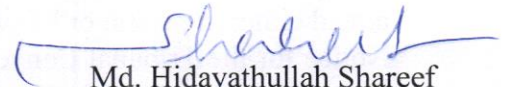
